Lakes Area & Kossuth County ECI: “Ten Hour IOSHA Safety Training Certificate Courses”

SPENCER, IOWA – Iowa Workforce Development will commit its resources to Iowa's prosperity by working to ensure the income security, productivity, safety and health of all Iowans. One goal is to reduce the incidence of injury or illness to workers by enhancing the ability to identify and control safety and health hazards. Employers can learn about potential hazards at their worksites and improve their occupational safety and health management systems by using IOSHA's consultation services and training opportunities.

The Lakes Area Employers' Council and Kossuth County (ECI) in conjunction with Iowa Workforce Development is offering two “Ten Hour IOSHA Safety Training Certificate” sessions in August for employers who are interested in promoting safety in their workplace. Both of the training sessions will be led by Mike Whitmore, Compliance Assistance Specialist with the Iowa Dept of Labor, Iowa Workforce Development.

SHARP and VPP are company recognition programs for safety and health management awarded by the Commissioner of Labor on behalf of the Governor of Iowa. Employers should note that this program is completely separate from the IOSH Enforcement staff, no citations are issued or penalties proposed, and it is confidential.
